Gaming (Control) (Amendment of Schedule) Order

In exercise of the powers granted under section 46 of the Gaming (Control) Act,
No. 11 of 2021 the Minister of Finance makes the following Order:

[Published 22nd September 2022 – Official Gazette No. 56 of 2022]

1. SHORT TITLE.

This Order may be cited as the Gaming (Control) (Amendment of Schedule) Order, 2022.

2. AMENDMENT OF FIRST SCHEDULE.

The First Schedule is amended as follows:

(a) by replacing Form 3 as follows:

3. AMENDMENT OF SECOND SCHEDULE.

The Gaming Control Act is amended in the Second Schedule paragraph 2, by inserting immediately after subparagraph (g) the following new subparagraph (i):

“ (i) two (2) certified/notarized government issued photo identification documents.

4. AMENDMENT OF THIRD SCHEDULE.

The Gaming (Control) Act is amended in the Third Schedule by inserting immediately after paragraph (1) thereof, the following new paragraph (2) as follows:

“ (2) The persons referred to in paragraph (1) shall complete the following Personal Questionnaire in satisfaction of the requirements for fitness and propriety and shall submit same to the Commission:

1. Have you at any time been charged or convicted of any offence by a civil, criminal or military court? (excluding minor Road Traffic offences). If so, please give details of charge, and if convicted, the date of conviction and full particulars of the offence and the penalty imposed.

2. Have you ever been the subject of investigation/disciplinary procedures, censured, disciplined by any professional body to which you belong or have belonged? If so, give particulars.

- (d) entered into a deed of arrangement, or other composition or arrangement with your creditors?

9. Has a bankruptcy petition ever been served on you? If pending, give details of the circumstances and if not pending, how was the matter resolved?

10. Have you, your company or your employer, previously dealt on a regular basis with any person carrying on a relevant activity who has, to your knowledge at any time, indicated that he is unwilling to effect further transactions with you, your company or your employer, by reason of any act or omission by you? If so, give particulars.

11. Will you be actively engaged in the business or the entity to which this application relates and devote the major portion of your time to it?

Please note that due diligence will be conducted on each Director, Senior Management member and major Shareholder at a minimum cost of US\$8,000 or EC\$21,600 (Non-Nationals). This cost is a basic fee and subject to the complexity of the investigation, may be increased on such terms as may be prescribed by the Commission."
