ISLAND OF NEVIS

In exercise of the powers conferred by **Section 64** of the **Nevis International Exempt Trust Ordinance, CAP. 7.03(N)**, the Minister responsible for Finance makes the following Regulations:

[Published 24th December 2024, Official Gazette No.77 of 2024]

1. Citation.

(1) These Regulations may be cited as the **Nevis International Exempt Trust (Fees) (Amendment) Regulations, 2024**.

(2) These Regulations amend Schedule 1 of the Nevis International Exempt Trust (Fees) Regulations as set out under the Nevis International Exempt Trust Ordinance, CAP. 7.03(N).

(3) These Regulations shall come into effect on the 1st day of April, 2025.

2. Interpretation.

In these Regulations, “Regulations” means the **Nevis International Exempt Trust (Fees) Regulations**.

3. Amendment to the Schedule to the Regulations.

The Schedule to the Regulations is amended by repealing and substituting the following table:
